9. CONTRACT AWARD FOR THE UNIVERSALLY ACCESSIBLE PLAYGROUND PROJECT (PW 2007.23) submitted by Director of Public Works/City Engineer. (F: 34.3B PW 2007.23)

ACTION: On motion by Council Member Rudolph and second by Council Member McCullough, the City Council: 1. Waived the minor bid irregularity of an unattached bid bond, and award a contract in the amount of \$326,293.22 to Micon Construction, Inc., of Placentia, California, for construction of the Universally Accessible Playground Project (PW 2007.23). 2. Adopted Resolution No. 2008-28 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKE FOREST, CALIFORNIA, AMENDING THE CAPITAL IMPROVEMENT PROJECTS BUDGET FOR 2007-2009. 3. Upon receipt of the executed contract documents from Micon Construction, Inc., reject all other bids received and authorize return of the Bid Bonds. 4. Authorized the Mayor to sign, and City Clerk to attest the contract with Micon Construction, Inc. 5. Authorized the City Manager to approve contract change orders up to a maximum ten percent (10%) of the contract amount. MOTION UNANIMOUSLY CARRIED.

10. NOTICE OF COMPLETION FOR SLURRY SEAL IMPROVEMENTS ON VARIOUS CITY STREETS (PW 2007.17B) submitted by Director of Public Works/City Engineer. (F: 64.4A PW 2007.17B)

Found that Bond Blacktop of Union City, California, has completed the construction of the Slurry Seal Improvements on Various City Streets Project (PW 2007.17B). 2. Authorized the City Clerk to submit said Notice of Completion for recordation to the Office of the County Recorder of Orange County, within ten days of the City Council approval, as required by Section 3093 of the California Civil Code. 4. Authorized the ten percent retention payment in the amount of \$35,289.20 to the contractor 35 days after the recording date of the Notice of Completion, providing no Stop Notices are on file with the City preventing the release of the final payment.
