Council Member Tettemer disclosed he is an employee of the Irvine Ranch Water District (IRWD); he does not work for the department which handles rate setting or billings; because IRWD, a public agency, is the only available purveyor of water in areas of the City, he has concluded, in consultation with the City Attorney, he has a non-interest in this warrant; and having made this disclosure he is permitted to vote on this item.

ACTION: The City Council adopted Resolution No. 2012-53 entitled: A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKE FOREST, CALIFORNIA, APPROVING THE AMENDMENT OF THE PERSONNEL RULES AND REGULATIONS.

\*10. CONSTRUCTION CONTRACT AWARD FOR GRADING AND DRAINAGE OF THE LAKE FOREST SPORTS PARK PROPERTY submitted by Director of Public Works/City Engineer. (F: 0400-10)

ACTION: The City Council: 1. Awarded a construction contract in the amount of \$4,917,100 to Road Builders, Inc., for construction of the Grading and Drainage of the Lake Forest Sports Park property (PW 2009.01). 2. Waived the bid irregularity for bid item # 1 by Road Builders, Inc. 3. Upon receipt of the executed contract documents from Road Builders, Inc., rejected all other bids and authorized return of the bid bonds. 4. Authorized the Mayor to sign, and the City Clerk to attest, the contract with Road Builders, Inc. 5. Authorized the City Manager to approve contract change orders up to a maximum ten percent of the contract amount.

\*11. NOTICE OF COMPLETION: CLEARING AND GRUBBING OF THE LAKE FOREST SPORTS PARK PROPERTY submitted by Director of Public Works/City Engineer. (F: 0400-10) (X: 0730-30)

ACTION: The City Council: 1. Found that Crew Incorporated, of Rancho Dominguez, California, completed construction on the Clearing and Grubbing of the Lake Forest Sports Park Property Project PW 2009.01.

2. Approved the Notice of Completion and authorized the Mayor to execute the document on behalf of the City. 3. Authorized the City Clerk to submit said Notice of Completion with the County Clerk-Recorder of Orange County, within 10 days of City Council approval, as required by Section 3093 of the California Civil Code. 4. Authorized release of the ten percent retention payment to the contractor in the amount of \$189,353.94, thirty (30) days after the recording of the Notice of Completion, provided no Stop Notices were on file with the City preventing release of the retention payment.
