Item 7: Bid Documents for Street Sweeping Services

- City Council will consider approving bid documents and authorization to solicit for street sweeping services. The City's street sweeping program helps reduce the amount of debris entering the storm drains and promotes cleanliness and aesthetics of City streets and parks. Routine services include weekly sweeping of all public residential and arterial streets and City-owned park parking lots, as well as emergency sweeping, special sweeping, and re-sweeps. The scope of work also includes new curb miles to reflect additional streets in newly developed areas and now requires the contractor to equip sweeping vehicles with GPS tracking devices.
- Item 8: Construction Contract Award for ADA Access Ramp Improvements Phase 7
 - City Council may approve a contract with Dash Construction to construct 36 access ramps generally located along Regency Lane, Osterman Road, Skylark Drive, Dimension Drive, and Lake Forest Drive between Regency and Pittsford. The project ensures compliance with the Building Code and the Americans with Disabilities Act. The contract amount is \$161,164.

- Item 9: December Monthly Treasurer's Report
 - The December 2014 Treasurer's Report provides information on the City's investment portfolio. All investments are in compliance with the City's Investment Policy.

Item 10: Request for Proposal for Building and Safety Services Contract

City Council may approve a Request for Proposal for Building and Safety Services beginning May 2015 with proposals due on February 11. The proposed scope of work identifies the responsibilities, tasks, and personnel to provide these services to the City. The building and safety services contract is paid with a portion of the fees collected by the City for building plan checks and inspections.

Discussion

Item 11: Consideration of Planning Commission Applicants

City Council will conduct nine applicant interviews for the Planning Commission and may exercise discretion to appoint three members to four-year terms and one member to a two-year unexpired term previously filled by Mayor Pro Tem Hamilton.

Item 12: Discussion Regarding the City's Membership in the League of California Cities

City Council may discuss the City's continued membership in the League of California Cities, and consequently, payment of the 2015 dues in the amount of \$18,988. The League was established as a way by which local cities may share information, discuss important policy issues, and form an advocacy group generally representing the interests of local communities. Presently, approximately 98% of all cities in California are members of the League. Additionally, the League tracks numerous bills during each legislative cycle and provides leadership regarding various issues affecting local governments.
