The Lake Forest Sports Park is gearing up for an actionpacked summer, kicking off with adult softball leagues four nights a week starting in June, with plans underway for adult basketball and volleyball leagues in the fall. In addition, over 20 sessions of City-led camps are also taking

Whatever you do this summer, we hope you get out and play!

Help Protect Wildlife – Introducing City Wildlife Ordinance

Did you know that feeding geese, ducks, and waterfowl bread and other food meant for people affects the birds' natural migratory patterns, is harmful to them, and creates undesirable conditions? This innocent activity causes overcrowding and can result in the rapid spread of avian diseases. Typical waterfowl diets include insects and grass that contain essential nutrients to survive, reproduce, and live a healthy life. Feeding waterfowl low nutrition foods such as bread and crackers contributes to water pollution, unsanitary conditions, and landscape degradation, which diminish the aesthetics and cleanliness of a park.

Village Pond Park is home to several species of waterfowl. To discourage park patrons from feeding the birds, and to protect the integrity of the park and the health of the birds, the City Council recently passed a Wildlife Ordinance focusing on public education and compliance enforcement through possible citations. We encourage all park visitors to take part in protecting the local waterfowl and their habitats – and doing their part to Keep Wildlife wild.

FAIR HOUSING An impediment to fair housing opportunity is any policy or practice that denies or adversely affects the provision of housing to a person in any protected class. Examples of a protected class include minorities, elderly, and disabled persons. As a recipient of annual Federal Community Development Block Grant funds, the City of Lake Forest is committed to furthering fair housing practices in the community and cooperates with the Fair Housing Council of Orange County to eliminate discriminatory practices county-wide. FAQs: MELLO-ROOS

With the development of Lake Forest's New Neighborhoods, residents are inquiring about how Mello-Roos applies to the newly developed areas. The following are a selection of some of the most frequently asked questions (FAQs) and answers regarding Mello-Roos in Lake Forest. As a reminder, Mello-Roos taxes assessed to Portola Hills homeowners are controlled by the County of Orange. For more FAQs, visit the City's website at *lakeforestca.gov/MelloRoos*.

What fees do the developers of the New Neighborhoods have to pay to the City and what can they be used for?

Each developer is required to pay various fees as part of the Development Agreements associated with the Opportunities Study Area ("OSA") New Neighborhoods.

- Community Facilities fees pay for the development of new public amenities such as the Lake Forest Sports Park and Recreation Center and the future Civic Center.
- Park Maintenance Fees pay to maintain certain public parks.
- The Lake Forest Transportation Mitigation (LFTM) fees fund intersection improvements throughout the City to ensure that the City's roadway infrastructure accommodates projected traffic volumes.
- The Foothill Circulation Phasing Plan (FCPP) fees fund other road improvements such as the completion of Alton Parkway.
- Affordable housing and neighborhood park requirements can be satisfied on site or, in some instances, through fees.

These funds cannot be used for general government purposes. The money collected is restricted and may only be used for the purposes identified specifically in the Development Agreements and other program documents.

Once the Baker Ranch development project is completed, how much will the developers have paid in fees to the City?

Upon completion of the Baker Ranch development, projections indicate the City will have collected approximately \$72 million in Community Facilities Fees, \$2 million in park maintenance fees, \$6.7 million in LFTM fees, and \$3.6 million in FCPP fees. In addition, the developer is required to pay an impact fee directly to the Saddleback Valley Unified School District of \$8,540 per housing unit prior to receiving building permits.

Will the new homes in the former auto center (Bake and Portola) be required to pay a share of the Mello-Roos fees associated with the Foothill Ranch Community Facilities District (CFD No.87-4)?

Yes. The new homeowners in the former auto center are required to pay a share of CFD 87-4 in the form of Mello-Roos payments.

Are the homes in the Baker Ranch development contributing their fair share towards the maintenance of the City's infrastructure?

Yes. While not a part of CFD 87-4, the Baker Ranch property was included in CFD 87-6 and made payments for its share of costs for the road infrastructure in the local area including arterials in Foothill Ranch. In addition, years ago, Baker Ranch was required by the County to pay its share for the Sheriff's Substation, Fire Station, and the Foothill Ranch Library in addition to other miscellaneous facilities. The owners of Baker Ranch decided to pay their obligation in cash instead of utilizing CFD financing. Therefore, the new homeowners in Baker Ranch do not pay Mello-Roos taxes.

Are any funds generated by new developers being used to pay off the existing bonds for Foothill Ranch CFD No. 87-4?

No, funds from one CFD or separate restricted source cannot be used to pay off a different bond obligation. The money collected from the developers is placed into restricted funds and may only be used for the purposes identified specifically in the Development Agreements and other program documents.

Spring Cleaning Tips!

Keep our creeks, lakes, and ocean clean while conserving water

- Clean patio furniture on your lawn or landscaped areas to provide plants a drink.
- Using a broom and dust pan to clean debris from your patios, walkways, and garage, instead of a hose, will provide additional materials to add to your compost.

Washing down dirt, debris and other pollutants into the gutter/ storm drain is illegal and wastes precious water resources.

Remember, anything that gets washed into the gutter ends up in our local creeks, lakes and the ocean.

Organic Garden Pest Control

Preventative maintenance and green insect repellants can keep insects from foraging in your home and garden.

A combination of keeping your home garbage and debris-free and using common household items can repel insects while protecting our local resources from pesticide pollution.

For rose bushes

- 6 cloves of garlic
- 1 tbsp. of baby shampoo
- 1 quart of water
- dash of cayenne pepper

Chopped and mixed will repel soft bodied bugs such as aphids.

For azaleas, rhododendrons, camellias, gardenias, and blueberries

Coffee and eggshells, sprinkled around the base of these plants will repel ants, snails, and slugs.

For ripening fruit

Equal parts ammonia and water mixed in cans and hung on fruit trees will repel wasps.

Crushed mint, bay leaves, cloves and eucalyptus wrapped in small cheesecloth squares can also be hung as a natural repellent.
