ACTION: The City Council: 1. Adopted Resolution No. 2014-33 entitled: A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKE FOREST, CALIFORNIA, APPROVING FINAL TRACT MAP NO.17446, CREATING A 12-NUMBERED AND 3-LETTERED LOT SUBDIVISION FOR CONDOMINIUM RESIDENTIAL PURPOSES ON 9.0-ACRES LOCATED AT THE SOUTHWEST CORNER OF BAKE PARKWAY AND PORTOLA PARKWAY. 2. Approved the Subdivision Improvement Agreement with Brookfield LF 147 LLC, A Delaware Limited Liability Company, to construct the subdivision improvements associated with Final Tract Map No.17446. 3. Accepted the Subdivision Faithful Performance Bond and the Subdivision Labor and Materials Bond both in the amount of \$101,666, the Subdivision Warranty Bond in the amount of \$10,167, and the Subdivision Monumentation Bond in the amount of \$19,953, as surety for the construction of the subdivision improvements.

Authorized the Director of Public Works/City Engineer to complete and submit the necessary Combined Transportation Funding Program application forms to the Orange County Transportation Authority for Catch Basin Automatic Retractable Screens.

Finance Director Neves reported the City has no investments in commercial paper at this time, and there is a limit of 5 percent within the portfolio guidelines.

13. REQUEST FOR PROPOSAL FOR VILLAGE POND PARK FINAL DESIGN SERVICES submitted by Director of Community Services.

Council Member Bass pulled this item for separate consideration. He asked for a revision to the Scope of Work.

ACTION: On motion by Council Member Bass and second by Council Member Voigts, the City Council: 1. Approved the Attached Request for Proposal for Village Pond Park Final Design Services. 2. Authorized Staff to Solicit Proposals for Final Design Services. MOTION UNANIMOUSLY CARRIED.

14. CONTRACT AWARD FOR SECURITY CAMERA SERVICES AT THE LAKE FOREST SPORTS PARK AND RECREATION CENTER submitted by Deputy City Manager/Director of Management Services.

Council Member McCullough pulled this item for separate consideration. She asked about the terms of the media agreement.

Deputy City Manager Rose stated the City's intention is to capture and save the footage of events or incidents only, and not all footage in general will be retained.

ACTION: On motion by Council Member McCullough and second by Council Member Voigts, the City Council: 1. Awarded a contract in the not-to-exceed amount of \$117,928 to Specialized Installations for Security Camera Services for the Lake Forest Sports Park and Recreation Center. 2.
