

## PUBLIC NOTICE PUBLIC HEARING TO BE HELD BY THE CITY OF LAKE FOREST PLANNING COMMISSION

Subject: Zoning Code Amendment 12-21-5483, a City-initiated Zoning Code Amendment to add

Chapter 9.60 of the Lake Forest Municipal Code to establish objective design standards

for new multifamily projects in the City.

**Project Description**: Zoning Code Amendment 12-21-5483 is a City-initiated Zoning Code Amendment to add Chapter 9.60 of the Lake Forest Municipal Code to establish objective design standards for new multifamily projects in the City. These standards will be used to review multifamily projects that are subject to a discretionary review and for projects that fall under a ministerial by-right review subject to the requirements of Senate Bill 35. The Planning Commission's action serves as a recommendation to the City Council.

Environmental Documentation: This proposed action is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) of the State CEQA Guidelines, which provides that a project is exempt from CEQA if the activity is covered by the common sense exemption that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA. Individual multifamily projects subject to discretionary review will be reviewed in accordance with CEQA; projects subject to ministerial approval under SB 35 are exempt from CEQA pursuant to Government Code Section 21080(b)(1).

All persons either favoring or opposing this proposal are invited to present their views before or at this hearing per the following special notice regarding public participation and comment. It is requested that any supportive documents and/or written comments be submitted prior to the public hearing.

**Agenda Description:** The Agenda descriptions are intended to give notice to members of the public of a general summary of items of business to be transacted or discussed. The listed Recommended Action represents staff's recommendation. The Planning Commission may take any action which it deems to be appropriate on the agenda item and is not limited in any way by the recommended action.

Email comments will be uploaded to the agenda packet and made part of the official public record of the meeting and will not be read at the meeting. To ensure staff

reviews all comments prior to the Planning Commission meeting, please submit email comments no later than 5:00 p.m. the day of the meeting.

**Public Comment at meeting**: Members of the public may provide in-person, verbal comments for any item during the meeting. Those wishing to provide comments will be asked to fill out a speaker card and provide it to the Commission Secretary prior to the commencement of the meeting.

Any petition for judicial review of a decision of the Lake Forest Planning Commission is controlled by the statute of limitations provisions set forth in Sections 2.50.010 and 2.50.020 of the Lake Forest Municipal Code ("LFMC") and Sections 1094.5 and 1094.6 of the California Code of Civil Procedure. Any action or proceeding to attack, review, set aside, or void any decision of the Lake Forest Planning Commission is controlled by Section 2.50.010 and Section 2.50.020 of the LFMC.

Any such action or proceeding that seeks judicial review of, attacks, or seeks to set aside or void any decision of the Lake Forest Planning Commission shall be limited to those issues raised at the hearing described in this notice or in written correspondence delivered to the Secretary to the Planning Commission, at, or prior to, the public hearing described in this notice, and must be commenced within the time limits specified in Chapter 2.50 of the LFMC.
