Qualifications unless otherwise specifically provided by law or ordinance of the City Council, are as follows: all members of boards and commissions of the City shall, at all times during their incumbencies be bona fide residents and registered voters of the City; no member of any board or commission shall be a City employee or person under an employment contract subject to the jurisdiction of the City Council; nor shall any person be a member of more than one (1) board or commission at any one time.
